## **PRIVACY POLICY AGREEMENT**

### **1. Information Collection And Use**

- 1.1 While using our Site, we may ask you to provide us with certain personally identifiable information that can be used to contact or identify you. Personally identifiable information may include, but is not limited to your name, email address and country ("Personal Information").

### **2. Cookies**

- 2.1 Cookies are files with a small amount of data, which may include an anonymous unique identifier. Cookies are sent to your browser from a web site and stored on your computer's hard drive.
- 2.2 Like many sites, we use "cookies" to collect information. You can instruct your browser to refuse all cookies or to indicate when a cookie is being sent. However, if you do not accept cookies, you may not be able to use some portions or features of our Site.
- 2.3 We also use the providers that are listed below to process data about your usage of our website so that we can adapt it to your interests in the best possible way. The following providers includes:
- 2.4 Google Analytics, a web analytics service that is provided by Google Inc. Google Analytics uses cookies along with text files that are stored locally on your computer to allow analysis of your usage of our Site.
- 2.5 The information generated by the cookie on the usage of the Site are usually transmitted to a Google server in the USA and might be stored there.
- 2.6 We also use IP Anonymization so that your IP address will first be truncated by Google within Member States of the European Union or in other states that are signatories to the Agreement on the European Economic Area.
- 2.7 Only in exceptional cases will the real or full IP address be sent to a Google server located in the US and truncated there.
- 2.8 Google will then use this information on our behalf to evaluate your use of this Site to compile reports on your usage and activity for us and to provide us with other services related to the Site usage, activity and Internet usage.
- 2.9 The IP address provided by Google Analytics within the framework of Google Analytics will not be combined with any other Google data.
- 2.10 You are free to prevent the storage of cookies by a setting in your browser software.
- 2.11 However, please note that you will most likely not be able to use most, if not all, of the functions of the Site.
- 2.12 You may also prevent the collection of data by Google by downloading and installing a browser plugin provided in the link below, <http://tools.google.com/dlpage/gaoptout?hl=de>

- 2.13 Google Analytics uses the following cookies: `_ga` (storage period of 2 years), `_gid` (storage period of 1 day) and `_gat` (storage period of 1 minute).

### **3. Server Log Data**

- 3.1 Like many site operators, we collect information that your browser sends whenever you visit our Site.
- 3.2 The legal basis for processing is based on our legitimate interest in ensuring system security, managing the Site technically and optimising the quality of service.
- 3.3 This Log Data may include information such as your computer's Internet Protocol ("IP") address, browser type, browser version, the pages of our Site that you visit, the time and date of your visit, the amount of data transferred to you and the time spent on those pages and other statistics.
- 3.4 These data will be forwarded to the authorities should a hacking attack occur.
- 3.5 No other transmission to any third parties takes place.

### **4. General Data Processing In The Context Of The Business Relationship**

- 4.1 Your data may be processed to fulfil a contractual relationship in the context of a business relationship or for processing that relationship.
- 4.2 Your data may be processed to deal with business transactions and to process the sale of service(s).
- 4.3 The transmission of relevant data in each case has a legal basis or fulfils a contractual relationship.
- 4.4 Moreover, transmission is also carried out to the following categories of recipients: Legal representatives, business partners, insurance companies, contract partners, administrative authorities, courts, tax advisors, auditors, accountants, banks.
- 4.5 Your data may be used for marketing or advertising purposes without your consent.

### **5. Communications**

- 5.1 We may use your Personal Information to contact you with newsletters, marketing or promotional materials and other information that are relevant.

### **6. Security**

- 6.1 The security of your Personal Information is important to us, but remember that no method of transmission over the Internet, or method of electronic storage, is 100% secure.
- 6.2 While we strive to use commercially acceptable means to protect your Personal Information, we cannot guarantee its absolute security.
